A Building Supply Centre and Fabrication Facility is considered to be one of these developments which, if properly designed and developed could add a service to both the residents of Inverness County and the travelling public.

(b) On page 17, Policy C-7, add after the words "grocery store" the words "Building Supply Centre including a building fabrication facility".






