CALL TO ORDER

Warden Duart MacAulay called the meeting to order at 2:00 p.m.

BUSINESS ARISING FROM MINUTES

Page 2 – Generator – Banks Road – Deputy Warden Mustard reported that a backup pump was purchased for the residents of the Banks Road and a further review will take place in the spring.

PRESENTATION BY CAPE BRETON ISLAND HOUSING AUTHORITY

Warden MacAulay welcomed Joan McKeough, Director, and Paul Burt, Senior Property Manager, CBIHA. Ms. McKeough reviewed the objectives of the housing programs, the

household income limits, eligibility criteria, vacancies etc. Ms. McKeough also reviewed the method of how the yearly Municipal contribution to the housing deficit is determined.

PRESENTATION BY BLAISE MACEACHERN – NOVA SCOTIA TRANS CANADA TRAILS

Blaise MacEachern updated Council on the Trans Canada Trail connection throughout Nova Scotia and in particular in Inverness County. The National Trans Canada Trail from Coast to Coast has been scheduled for completion by 2017. Mr. MacEachern reviewed the challenges and options for the land and water route connections for Inverness County. Mr. MacEachern thanked Council for their support in principal for these connector options.

CORRESPONDENCE

SERVICE NOVA SCOTIA & MUNICIPAL RELATIONS

Correspondence was received from the Minister of SNSMR advising that they are unable to assist in funding for the Maple Street Sewer Extension in Inverness at this time.

TRANSPORTATION & INFRASTRUCTURE RENEWAL

Correspondence received from the Minister of Transportation & Infrastructure Renewal informing Council that street lighting on provincial secondary roads is a municipal responsibility. He has asked department staff to conduct an investigation to evaluate the need for illumination at the Point Cross Bridge and Council will have an update when this investigation is complete.

TRANSPORATION & INFRASTRUCTURE RENEWAL

Correspondence received from Steve MacDonald, Area Manager, advising that an evaluation was carried out with respect to the request for a hidden driveway sign on Egypt Road (civic #928) and a hidden driveway sign is not warranted. Brush along the northbound approach will be removed in the upcoming maintenance season to further improve sight lines.

DEPARTMENT OF AGRICULTURE – DESIGNATION UNDER THE FENCES & DETENTION OF STRAY LIVESTOCK ACT

Correspondence received from the Dept. of Agriculture advised that Inverness County has not been designated under the Fences & Detention of Stray Livestock Act. Designation will enable the County and its residents to have an additional avenue through a Fences Arbitration Committee to address issues.
