#### PRESENTATION BY VERONIKA BRZESKI – ECOLOGY ACTION CENTRE

Ms. Brzeski reviewed the information that was carried out on Climate Change Adaption in the Cheticamp area. Ms. Brzeski focused on the sea level rise and the extreme storm surge predictions to indicate how the coast and infrastructure may be affected in the next century.

Ms. Brzeski suggested that the County use some of the research carried out in Cheticamp when working on the Municipal Climate Change Action Plan.
