### MI-CARME CENTRE

Councillor LeBlanc advised that the Mi-Carme Centre will be open from March 11-13 for the Mi-Carme celebrations.

## INVERNESS COUNTY HOME SUPPORT

Councillor LeBlanc will provide information to Council when the funding is finalized for the Inverness County Home Support Program.

## TOURISM STRATEGY

That the Tourism Strategy for the County be approved in the amount of \$144,000.

## WINTER STORMS

Deputy Warden Poirier expressed appreciation to the Dept. of Transportation plow operators for the prompt work they provided in removing snow over the past several months.

### SEASONAL WORKERS

Deputy Warden Poirier mentioned that there could be a problem recruiting workers for the fish plant in Cheticamp and indicated that in the next several months he may be asking for support for seasonal immigration workers.

### **OUTDOOR RINK - PLEASANT BAY**

Deputy Warden Poirier congratulated the residents of Pleasant Bay for the work they carried out on their outdoor rink and noted that the residents are organizing future winter activities.

## CELL PHONE SERVICE

Deputy Warden Poirier continues to be concerned with the lack of cell service in the Pleasant Bay area and noted that lack of cellular service presented a problem when the tour bus overturned last year in Neils Harbour.

#### LAND VALUE PROTECTION

Councillor Betty Ann MacQuarrie asked that the Land Value Protection Resolution be added to the agenda for the next Policy Committee meeting.

### MARGAREE AIRPORT

Councillor MacQuarrie asked for clarification as to why previous discussions for an airport in Strathlorne were discontinued. Warden MacAulay explained that due to a problem with wind patterns this location was not practical. Also the Margaree Airport would be less costly as the capital asset is already invested in Margaree.

## STRAIT RICHMOND HOSPITAL - BLOOD COLLECTION

Councillor Dwayne MacDonald advised that blood collection at the Strait Richmond Hospital will now be sent to the lab at St. Martha's Hospital in Antigonish for analysis.

That a letter be forwarded to GASHA asking that the status quo for blood collection service be maintained at the Strait Richmond Hospital.

# **COMMUNITY MAILBOXES – MILLVILLE**

Councillor MacDonald asked that a letter be forwarded to Canada Post requesting that the parking lot at the community mailboxes in Millville be kept ploughed.

### DEPARTMENT OF TRANSPORTATION

Councillor MacDonald asked that the Dept. of Transportation be contacted requesting that the Millville sign be re-installed.

## **CREIGNISH REAR ROAD**

Councillor MacDonald provided information on a situation where an ambulance was called out to a residence on the Creignish Rear Road which a portion of it is not plowed in the winter time and then had to back track from Creignish to the General Line Road. Councillor MacDonald asked that the EDPC, DOT, and 911 be contacted for clarification.

# KRAFT HOCKEYVILLE COMPETITION – INVERNESS

Councillor MacDonald on behalf of Councillor Mustard asked for support for the community of Inverness in the Kraft Hockeyville Competition.

# CLOSURE OF PROVINCIAL PARK OFFICE - WHYCOCOMAGH

Warden MacAulay advised that the office at the Provincial Park in Whycocomagh is closing with a loss of 6-7 jobs. Warden MacAulay and Councillor MacDonald are meeting with staff to discuss this closure.

# TOURISM SIGNAGE STRATEGY

Joe O'Connor explained that the County is exploring the possibility of cooperating with Richmond County on a Joint Signage Strategy and a meeting will be held in the next several weeks.
