CALL TO ORDER

Warden Duart MacAulay called the meeting to order at 1:35 p.m.

BUSINESS ARISING FROM MINUTES

PRESENTATION BY ANDREA COOMBS, PHONSIE FARELL & DENNIE BOUTLIER - PORT HAWKESBURY PAPER

Information was provided from representatives of the Port Hawkesbury Paper with respect to the changes in operations and staffing as well as the types of paper now produced at the mill. The wood supply areas and the licensed crown lands were also discussed.

PRESENTATION BY REVERAND DONNA TOURNEUR & JIM FOULDS – UNESCO

Reverand Tourneur provided information on the two main projects they are currently working on - 1) Web-based Atlas of the Bras d'Or Lakes and 2) Science Education. The web-based atlas is an inventory of community groups around the watershed area which will be incorporated into a web-based public atlas of the Bras d'Or's and will continually be updated with additional information. The Science Education is a curriculum development using the Bras d'Or Lakes to teach habitat in grade 4 science.

Council adjourned for a five minute break.

Warden MacAulay called meeting back to order at 3:05 p.m.

PRESENTATION BY KRISTEN OVERMYER-BIOMASS GASIFICATION **OPPORTUNITIES**

Mr. Overmyer explained the differences with biomass gasification and other biomass technologies. Biomass gasification is used in many places that natural gas is used and has less of an environmental impact. Mr. Overmyer reviewed the possibilities for Inverness County if implemented in large community facilities, regional industry plants or large farms.

PRESENTATION BY MIKE MAHONEY – SEASIDE COMMUNICATIONS

Mr. Mahoney provided information on the community support plan embarked by Seaside Communications that will result in a \$2,000. cash donation per year to two fire departments from each county where Seaside serves customers, combined with free internet access & wifi in various fire halls throughout the Province. Seaside will also be constructing a Web Portal that will provide each volunteer fire department with their own web space, as well as a donation page where members of the community will be able to make donations to the location of their choice. Mr. Mahoney reviewed the sponsorship package and asked that the County participate. Warden MacAulay advised that this request would be referred to an Audit Committee meeting.

FOOD SECURITY COMMITTEE

Seven applications have been received for the Food Security Committee which will be reviewed at a later date.

CAPE BRETON DISTRICT HEALTH AUTHORITY TASK FORCE

Joe O'Connor advised that he has been appointed to a task force for the Cape Breton District Health Authority to review patient flow and long waits in emergency rooms.

EASTERN COUNTIES REGIONAL LIBRARY

Councillor MacQuarrie reported that the board of the Eastern Counties Regional Library met with Provincial Representatives to discuss budget cutbacks. Laura Emery, Chief Librarian will be contacting the County to make a presentation to Council.

PLANNING & ADVISORY COMMITTEE

FIRST READING – APPLICATION BY RAYMOND DEVEAU TO AMEND THE CHETICAMP MUNICIPAL PLANNING STRATEGY & LAND USE BY-LAW

Warden MacAulay advised that a Municipal Planning & Advisory Committee meeting was held previous to Council and it was recommended that this application proceed to Council for First Reading.

That the Cheticamp Municipal Planning Strategy and Land Use By-Law be amended as follows:

- Amend the preamble to the Mixed Use (MU) Zone in the MPS to reflect that the Cheticamp Development Commission no longer owns the land zoned Mixed Use (MU), and to update the permitted used in Policy 4-2 to allow development of a marina and boat storage and service facility within the Zone;
- Amend the text of Part 14 of the LUB (Mixed Use (MU) Zone) to permit marinas and marina facilities and boat storage and servicing facilities, and to establish a 1.83 metre (6 foot) setback from the ordinary high water mark, and:
- Amend the Zoning Map of the LUB so that the boundary of the Mixed Use (MU) Zone follows the lot lines of the subject property.
- Part 14 Mixed Use (MU) Zone to allow for development of the following –
- Marinas and marina facilities;
- Boat storage and servicing facilities;

That the First Reading of the application by Raymond Deveau to amend the Cheticamp Municipal Planning Strategy & Land Use By-Law to allow construction of a Marina & Boat Storage & Service Facility on properties in Cheticamp (PID's 50206127 & 50206143) be approved.

DATE OF PUBLIC HEARING

Council agreed that staff set a date for a Public Hearing to be held in Cheticamp.

CORRESPONDENCE

MINISTER OF FINANCE

Correspondence was received from the Minister of Finance advising that Council's request for a fuel tax exemption for mining companies will be reviewed during budget discussions.

PETITIONS AND RESOLUTIONS

CROWDIS BRIDGE

Councillor LeBlanc advised that a meeting was held with the Minister of Transportation and he agreed to review the time frame for the replacement of the Crowdis Bridge.

ROAD NAME CHANGE - WEST BIG INTERVALE ROAD

Councillor LeBlanc asked that the County reiterate the importance of having the upper portion of the West Big Intervale Road changed to "Sugarloaf Valley Road".

MARGAREE HARBOUR – RANGE LIGHTS

Councillor LeBlanc explained that the Federal Dept. of Fisheries is divesting the two range lights at the harbor in Margaree. MADA are interested in taking over ownership and future maintenance of these lights. Councillor LeBlanc provided a letter of support to MADA from the County.

MEAT COVE ELECTORAL DISTRICT

Councillor Poirier advised that the Chief Electoral Officer should have a decision shortly with respect to the electoral boundary change for Meat Cove.
