# PRESENTATION BY JOHN MALCOLM - CAPE BRETON DISTRICT HEALTH AUTHORITY

Warden MacAulay welcomed John Malcolm. Mr. Malcolm explained that 80% of the after hour surgeries at the Inverness Consolidated Memorial Hospital could have been conducted during regularly scheduled surgery hours and due to the deficit this service was removed from the hospital.

Mr. Malcolm advised that the Renal Dialysis unit will be opening soon at the ICMH and the installation of a CT scan should be announced in 2012/13.

Council expressed concern as to how the closure of the after hour surgeries at the hospital was announced with no prior consultation with hospital staff and whether there will be more services lost.
