## APPROVAL OF OPERATING BUDGET – 2016 FISCAL YEAR

RESOLVED that pursuant to Section 72 of the Municipal Government Act, of the Province of Nova Scotia, the Municipal Council of the Municipality of the County of Inverness estimated that sums amounting to \$14,241,561.00 are required for the lawful purpose of the said municipality for the year ending March 31, 2015, after crediting the probable revenue from all sources other than the rates of the said year and making due allowances for the abatement and losses which may occur in the collection of taxes for the said year which may not be collected or collectible.

FURTHER RESOLVED that the Council hereby authorize the levying and collection of a commercial property rate of \$1.85 and a residential and resource rate of \$1.02 per one hundred dollars of the assessed value of property and on the assessment roll which the said Council deems sufficient to raise the sum required to defray the expenditures of the said Municipality of the said year.

#### DEPARTMENT OF TRANSPORTATION

Councillor LeBlanc expressed concern with the condition of the roads and would like to see an assessment carried out of the roads and in particular the Old Cabot Trail Road. Councillor LeBlanc would also like an update on the status of the guard rail on the East Margaree Road and asked that a letter be sent to the DOT to this effect.

## CBIHA - ELEVATOR - GRAND ETANG

Warden MacAulay noted that he received a copy of a petition from the Board of Directors of the LeMoine Development Association to the CBIHA in support of the installation of an elevator at the Seniors Complex in Grand Etang.

## CBU EVENT - INVERNESS

Councillor Jim Mustard provided information on the CBU event to be held in Inverness on May 12<sup>th</sup> at the Council of the Arts Centre.

#### STREET LIGHTS

Councillor Mustard questioned the status of the contractor for street light repairs and Garett Beaton advised that a contractor has been retained.

## PROVINCIAL BUDGET CUTS

Councillor Mustard expressed concern with the provincial cutbacks and in particular with the obstetrics doctors. Warden MacAulay suggested inviting the Provincial Cabinet to host a cabinet session in the County.

## ROAD NAME CHANGE APPROVAL

### VICTORIA COUNTY – PROVINCIAL BUDGET CUTS

Councillor Betty Ann MacQuarrie commented on the correspondence received from Victoria County in particular with respect to the closure of the provincial courts in the rural areas and the cost related to the RCMP officers having to travel greater distances to attend court.

That correspondence be forwarded to Premier MacNeil, with copies to Deputy Premier Diana Whalen, and MLA Allan MacMaster expressing disappointment with the closures of the Gaelic Affairs office in Mabou and the Land Registry Office in Port Hood as well as the transfer of the Provincial Court to the Justice Centre in Port Hawkesbury.

## LAND VALUE PROTECTION RESOLUTION

Councillor MacQuarrie questioned the status of the land maps from the EDPC. Joe O'Connor advised that Bryne Butts is looking into this.

#### STREET LIGHT

Councillor Dwayne MacDonald would like a street light at the intersection of St. Ninian and the Rear Intervale Rd in Judique. Councillor MacDonald will check with the DOT to see if they will install a light at this location.

#### MILLVILLE SIGN

Councillor MacDonald questioned the status of the Millville sign. We will check with the DOT.

#### DEPARTMENT OF TRANSPORTATION

Deputy Warden Alfred Poirier expressed disappointment with the lack of respect from the DOT. He feels that since the loss of the two DOT employees in the north of the County the roads are not maintained as well as previous years.
