CALL TO ORDER

Warden Duart MacAulay called the meeting to order at 1:50 p.m.

APPROVAL OF MINUTES

That the minutes of the Municipal Council Meeting held on September 10, 2012, be approved.

BUSINESS ARISING FROM MINUTES

FIRST READING – FRACTURING BY-LAW

Moved by: Councillor Jim Mustard Seconded by: Councillor Gloria LeBlanc

Carried.

Therefore the Council of the Municipality of the County of Inverness Enacts as follows:

- 1) No person, partnership, joint venture, or trust or any corporate, governmental, or quasi-governmental entity or joint venture thereof may utilize either chemical (slickwater) hydraulic fracturing, (otherwise known as High Volume Hydraulic Fracturing (HVHF) or, simply, fracking) or any pressurized technology or agent, including but not limited to liquefied hydrocarbon gases, to fracture (frack) underground rock structures as a means to explore for or extract oil or methane gas from drilled wells within the territorial jurisdiction of Municipality of the County of Inverness.
- 2) The Municipality of the County of Inverness may adopt policies reasonably related to implementation and enforcement of this By-Law.
- 3) Any violation of this By-Law is hereby declared to be a nuisance.
- 4) Any person, partnership, joint venture, or trust or any corporate, governmental, or quasi-governmental entity or joint venture thereof which violates this By-Law is guilty of an offence and shall be subject to a fine for each day a violation of this By-Law continues in the amount of \$10,000.
- 5) If any clause, sentence, section, or provision of this By-Law is determined by any court of competent jurisdiction to be invalid in any respect, each remaining clause, sentence, section and provision of this By-Law shall remain undiminished and in full force.

It was noted that Councillor Dwayne MacDonald will support the First Reading to allow by-law to proceed to Public Hearing to hear concerns from the public.

It was the consensus of Council that the Public Hearing and Second Reading be delayed until after the Municipal Election.

MACKINNON TRUCKING

Councillor Jim Mustard reviewed the recommendations from the Inverness Area Advisory Committee with respect to the Duncan MacKinnon matter 1) Develop a light industrial park with appropriate environmental safeguards and standards; 2) Acquire land through the Dept. of Natural Resources or privately as soon as possible; 3) Proceed with enforcing by-law infraction on River St. against MacKinnon Trucking; 4) Concerns around safety of present site being used on River St. with regards to environmental damage due to possible fuel and other chemical spills.
