Warden MacAulay welcomed Cecil Cashin who provided information on the Strait Area Ground Search & Rescue. Mr. Cashin advised that they have been in existence for thirty years and have approximately 80 members. Mr. Cashin reviewed their coverage area which includes several areas in Inverness County.

The Strait Area Ground Search & Rescue is requesting that the County designate them as an emergency service provider which will then qualify them for Provincial and Federal grants and funding.

Mr. Cashin also advised that they are registered with the Project Lifesaver Association of Nova Scotia and have purchased the necessary equipment to assist Project Lifesaver clients who are at risk of wandering.

**Whereas:** The members of the Port Hastings Advisory Committee freely gave their time to do the same, and,

<u>Whereas:</u> The Municipality of the County of Inverness endorsed their plan for the Port Hastings Plan Area in the form of By-Laws, and,

Whereas: Part 6, Section 1, subsection (b) of the Port Hastings Plan Area By-Law states, "No sign shall be erected without obtaining a development permit from the Municipal Development Officer," and,

<u>Whereas:</u> Part 6, Section 5, of the Port Hastings Plan Area By-Law states, "Notwithstanding signs which do not conform with provisions of Sections 6, 7, 8, and 9 of this Part, the following signs shall not be permitted in any zone," and,

Whereas: Part 6, Section 5, subsection (m) of the Port Hastings Plan Area By-Law states, "Signs not related to any business or use located on the lot or premises," and,

<u>Whereas:</u> Part 6, Section 5, subsection (g) the Port Hastings Plan Area By-Law states, "Any sign which no longer advertises a bona fide business conducted, or a product sold,", and,

<u>Whereas:</u> Part 6, Section 4, subsection (e) of the Port Hastings Plan Area By-Law states, "Signs erected by a government body, or under the direction of such body, and *bearing no commercial advertising*, such as traffic signs, railroad crossing signs, safety signs, signs identifying public schools, or public election lists," and,

<u>Whereas:</u> Part 6, Section 2, subsection (b) of the Port Hastings Plan Area By-Laws states, "All signs and all parts thereof shall be kept in a good state of repair and maintenance," and,

<u>Whereas:</u> More than 30 signs have been erected in the Port Hastings Plan Area without permit, (Part 6, Section 1, subsection (b)), and,

Whereas: Two of these signs have been erected for, or by, a neighbouring municipal government and bear commercial advertising, (Part 6, Section 4, subsection (e)), and said signs no longer advertise a bona fide business conducted, or a product sold (Part 6, Section 5, subsection (g)), and

Whereas: The remaining sign from the neighbouring municipality, while allowed under Part 6, Section 4, subsection (e), is in a state of obstruction, and disrepair, (Part 6, Section 2, subsection (b)) and,

<u>Whereas:</u> The people of Port Hastings feel that they were asked to perform a fruitless task, because the Municipality of the County of Inverness has failed to keep it's commitment to the people of the Port Hastings Plan area, by failing to enforce the Port Hastings Plan Area By-Law,

**Be It Resolved:** That the Municipality of the County of Inverness enforces the Port Hastings Plan Area By-Law. That the following actions be taken:

- 1. That the District Planning Officer send notice to all offenders, notifying them of their breach of the By-Law, along with a copy of the By-Law, and the Part, Section, and Subsection of the By-Law of which they are in breach, and demanding compliance within a 30 day period, and
- 2. That any sign in breach of the By-Law after the 30 day period be removed by the Municipality of the County of Inverness' Public Works Dept. as a priority, without delay, and,
- 3. That notice be posted on the Municipality of the County of Inverness' website, and printed for two consecutive weeks in local, regional, and provincial newspapers, advertising of the intention of the Municipality of the County of Inverness to rigorously enforce the Port Hastings Plan Area By-Law; that any sign erected in violation of the Port Hastings Plan Area By-Law will be removed after 30 days without notice, and,
- 4. That after this notice is given on the Municipality of the County of Inverness' website, and in local, regional, and provincial newspapers, any signs erected in violation f the Port Hastings Plan Area By-Law be removed without notice, as a priority, and without delay by the Public Works Dept. of the Municipality of the County of Inverness, after thirty days.
