# REN INTER-MUNICIPAL AGREEMENT

Warden MacAulay reported that the framework for the creation of a Regional Enterprise Network between the Counties of Inverness, Richmond, Victoria and CBRM has been finalized. The startup funding is still being negotiated and the Board of Directors will consist of eight business or community members (two from each municipality. The name has been changed to Business Cape Breton.

Councillor LeBlanc provided an unsightly premises complaint report from a citizen on the East Margaree Road of an old barn which has fallen down. Councillor LeBlanc asked that this complaint be forwarded to the Eastern District Planning Commission.

#### STORM SEWER - MACISAAC STREET

Deputy Warden Mustard asked for an update from the Dept. of Transportation on the storm sewer issue on MacIsaac St.

## **ROAD NAME CHANGE – HILLTOP LANE**

## NOVA SCOTIA POWER

Councillor Betty Ann MacQuarrie informed Council that she has received complaints from residents in the Port Hood area with respect to trees on power lines in this area. Councillor MacQuarrie has been in contact with NSP and was concerned with the time frame for work to be carried out.

## DEPARTMENT OF TRANSPORTATION

Councillor MacQuarrie asked that a letter be forwarded to Bernie Murphy, Traffic Engineer, requesting a reduction in the speed limit or a warning sign at the turn by the Chestico Museum in Port Hood. Also a warning sign of the rough section of road approaching the Captain's River Bridge in Harbourview (Port Hood).

### NON RESIDENT LAND OWNERSHIP

Councillor MacQuarrie advised Council that she has carried out some research on non resident land ownership and provided a copy of a resolution with respect to land value protection to be provided to Council.

## **DEPARTMENT OF TRANSPORTATION – SIGNAGE**

Councillor Dwayne MacDonald explained the need for a "Children Playing" sign at 1620 Crandall Rd and questioned whether the county has a policy with respect to this type of sign. Joe O'Connor advised that the county does not install these types of signs.

Councillor MacDonald expressed concern with the illegal dumping which is occurring in the County. Councillor MacDonald is currently drafting an illegal dumping policy.
