PRESENTATION OF OPERATING BUDGET- 2011-2012

Warden Duart MacAulay advised that the Operating Budget for 2011-2012 was reviewed at an Audit meeting held earlier today, and the following was recommended:

RESOLVED that pursuant to Section 72 of the Municipal Government Act, of the Province of Nova Scotia, the Municipal Council of the Municipality of the County of Inverness estimated that sums amounting to \$12,483,499 are required for the lawful purpose of the said municipality for the year ending March 31, 2012, after crediting the probable revenue from all sources other than the rates of the said year and making due allowances for the abatement and losses which may occur in the collection of taxes for the said year which may not be collected or collectible.

FURTHER RESOLVED that the said Council hereby authorize the levying and collection of a commercial property rate of \$ 1.85 and a residential and resource rate of \$1.02 on one hundred dollars of the assessed value of property and on the assessment roll which the said Council deems sufficient to raise the sum required to defray the expenditures of the said Municipality of the said year.

AND BE IT FURTHER RESOLVED that the area rates be established as follows for the following areas:
