### **PRESENTATIONS**

### Mary Tulle, Destination Cape Breton

DCBA was formed in 2011. This in turn led to a marketing levy for the entire island of Cape Breton. Strong funding came from Enterprise Cape Breton Corporation and Atlantic Canada Opportunities Agency with initial program and core funding from Tourism Nova Scotia. A mandate was established: DCBA is dedicated to the promotion and enhancement of tourism on Cape Breton Island. A tourism strategy was adopted which consisted of research, product development and marketing. Website sessions are up 43% over 2016 adjusted non-Trump Bump sessions. Followers on social media such as Twitter, Facebook and Instagram are all up respectively 15%, 52% and 157%. Focus is on meetings and events, corporate incentive travel, sporting events. Strong sales focus in partnership with key stakeholders such as Cape Breton Partnership, municipalities, Chambers of Commerce, CBU, NSCC, First Nation Communities, hotel properties, offsite venues. USA Today Reader's Choice Awards ranked the Cabot Trail #1as the best scenic drive in Canada, Cape Breton Highlands National Park #1 as the best national park in Canada and The Bras d'Or Lake #3 in the best cottage region in Canada. This year has seen the best spring and summer seasons on record. Winter tourism is also being explored. There will an island wide session the first of March and anyone can attend.

### **DEPARTMENT REPORTS**

### Finance/Interim CAO

- Escribe training for council will be done when the new CAO has been hired and it will take approximately an hour.
- The Housing Coordinator will be starting on Monday, January 22<sup>nd</sup> and it will be two days a
  week in the municipal building and the other days in St. Joseph du Moine.
- Shared IT services with other municipalities is being looked at and possible funding is available through municipal affairs.
- The receivables for the year seem to be ahead of schedule. It is usually 90% at the end of the vear.
- The resolution for the mortgage for Foyer Pere Fiset is being sent to the Minister of municipal affairs as well as the minister of community services.
- The organizational review has been implemented, but it needs to be adopted by council. The strategic plan final draft has not been received.

### **Public Works**

- Archibald Engineering have a conceptual plan for renovations to council chambers. CBREN
  has funding available to utilize the space that is available in this building with such things as
  community meeting space, office rental, etc. Hopefully the renovations will be completed by
  March 31, 2018.
- The Judique water project has been shut down until the spring and a request was submitted for an extension for completion date, but it was not approved by the province as of yet.
- A direct contact at Nova Scotia Power would be ideal to avoid an issue like we had in Mabou on the weekend. This could be input into the emergency plan for the county.

There is also a meeting in Whycocomagh at the water front centre Jan 9<sup>th</sup> at 12 noon of the chiefs, warden and mayor before the proclamation is made. Deputy Warden Poirier will attend the Whycocomagh meeting in place of the Warden.
- Inverness Visitor's Centre invoice will be brought to an audit committee meeting.
- Put together a budget for the crosswalks in Inverness for council.
- There is a forestry meeting in Middle River on January 20<sup>th</sup> to find out if there is enough interest to develop a forestry hub. Municipalities would be involved to bring interested parties together.
