## Pan Cape Breton Food Hub – Alicia Lake and Marilyn MacDonald

The food hub continues to make it easy to get food from the producers to the consumers. Food consumption has increased again in the last year. There continues to be more education by means of newsletters, social media, workshops, etc. The food hub taps into urban areas such as Sydney. Sales are up, revenue for vendors is up. Inverness County has been very supportive of the food hub as have other municipalities on Cape Breton Island. There are 41 producers island wide and 7 food hubs that work with Department of Environment for inspection and food handling. ## Inverness County Home Support Society – Angie MacEachern

The Inverness County Home Support Society is a not for profit agency that deliver home support services throughout Inverness County. It an agency of the Department of Health and Wellness, as well as, Continuing Care. Home support services enable client independence, assist with unmet needs and maintain quality of life in client's homes. These services allow clients to remain in their own homes and continue with quality of life they have become accustomed too. Some of the services offered are: personal care, light housekeeping, meal prep, respite services and other approved tasks. The agency has a staff of eight including, but not limited to the director, nurses, administrative assistant, bookkeeper. There is also a board of directors from within the county. There are currently 53 home support workers who are required to have continuing care certification. Staffing is always a challenge. The agency is completely funded through Dept of Health & Wellness at a rate set per hour of direct service to clients. Therefore, this makes meeting budget

another challenge. Budget has not been met since 2012. The agency is asking council to write a letter, on behalf of the agency, to show continued support of the home support society in Inverness County. Council is in support of the agency and will write a letter as they have done in the past. The agency will continue to work closely with health and wellness on budgeting issues.
