CHETICAMP ASSOCIATION FOR COMMUNITY LIVING – Recommendation that this be addressed during the budget process for review in consideration of the Green Door.

COMMUNITY COMMITTEE CHETICAMP LEMOINE – Deputy Warden would like to have both English and French speaking members of the committee. Deputy Warden will follow up with the chair of the committee and keep council up to date.

COMMUNCATIONS POLICY – Recommend to council that a notice of motion for the "Communications Policy" go to the next regular council meeting.

BUDGET PROCESS – March 5th and 12th have been set aside for budget presentations.

Deputy Warden was excused for a meeting in Halifax.

STAFF REPORTS -

CAO – Councillor Dowling asked for an update on the Judique water and Keith MacDonald responded that a contractor would be starting next week to install new equipment to bring the plant back on line.

TOURISM AND CULTURE – Warden MacQuarrie asked Donna MacDonald what equipment was loaned out by the department. Donna replied that it was skis and snowshoes.

FINANCE – Councillor Mustard asked Tanya Tibbo if she was contacted by Scotia Wind regarding community development funds. Tanya was not contacted and Councillor Mustard will forward her the email for Scotia Wind.

Councillor Dowling congratulated the Finance Department staff on a job well done regarding the financial condition index for 2017/18 fiscal year.

There were only two properties vested in by the Municipality at the last tax sale.
