PRESENTATIONS

NOVA SCOTIA POWER: PAUL CASEY; VP OF TRANSMISSION AND DISTRIBUTION AND DELIVERY

Mr. Casey spoke specifically on Hurricane Dorian, and the restoration efforts during and following the storm. Safety was stressed as the most critical factor for Nova Scotia Power staff during the restoration. From a power systems perspective, this storm was much larger than any weather event the province had ever seen before. Approximately 412,000 customers were impacted at the peak of the storm. Nova Scotia Power and Municipalities all must work closely with EMO to ensure critical infrastructure is on priority lists, and updated on a regular basis. Vegetation management investment is ongoing.

CAPE BRETON PARTNERSHIP: CARLA ARSENAULT; EXECUTIVE DIRECTOR

Ms. Arsenault spoke on the Cape Breton Unama'ki Economic & Population Growth Strategy. The Partnership recognizes the importance of the entire island working together toward a common goal. The potential areas of focus for the strategy include population growth, labour shortages, infrastructure gaps, technological advances, and entrepreneurship. A consultant has been hired and public engagements sessions will occur over the coming months. A final strategy will be in place by February. The public is encouraged to take the online survey and be part of the engagement process.

ATLANTIC FISHERIES FUND: JAMES MULLINS: SEAFOOD STRATEGIST

Mr. Mullins spoke on the purpose of the Atlantic Fisheries fund; to transform and drive innovation in the Atlantic fish and seafood sector through innovative processes, infrastructure investments, and science partnerships. In Inverness County there was \$79,000,000 in reported seafood and aquaculture purchases in 2018. Mr. Mullins outlined the commercial and non-commercial organizations that can apply, and provided examples of approved projects such as

innovation in harvesting, processing, and aquaculture. Fisheries and Aquaculture are open to meet with any association or group in the municipality seeking further information on this fund.

COMMUNITY HEALTH BOARDS: MARIE AUCOIN; NORTH INVERNESS COMMITTEE MEMBER

Community Health Boards are an advisory body to the Nova Scotia Health Authority. The Community Health Boards ensure that community voices are considered in provincial health planning. The 2018 Community Health Survey identified factors impacting overall health. Factors in North Inverness include culture, social environment, gender, income, working conditions, literacy, and social status. The board is eager to partner with the Municipality to help address some of the challenges that negatively impact the health of residents and communities.
