UPDATE: Food Hamper Program, Charlotte MacDonald, Manager of Recreation

Since School resumes on September 8, 2020, the Pandemic Response Team has suspended the Hamper Program as of August 27th. The Breakfast Program within the schools will be reinstated. The Hamper Program was in partnership with SchoolsPlus, and it continued into the summer. Ninety six families were eligible for the Gift Card Program for groceries. Many community partners were involved in this initiative, including SchoolsPlus, Strait Area Transit, The Salvation Army, Good Food Foundation, Nova Scotia Teacher's Union, and local fire halls. The Port Hood Fire hall served as home base for the distribution. In addition, one hundred thirty activity kits were distributed over the summer. Should the need continue, the Pandemic Response Team will continue to seek out funding partners for future distributions. Many positive comments to this initiative were received via the participant survey.

UPDATE: Vacation Locally Campaign – Donna MacDonald, Director of Tourism and Culture

Following the lead of Destination Cape Breton, the Department of Tourism and Culture promoted the importance of local residents and Atlantic Canadian visitors to travel locally, and "explore home". Residents were directed to local visitor information centers and to support local businesses.

UPDATE: Music Mondays - Donna MacDonald, Director of Tourism and Culture

Music Mondays is a facebook campaign that promotes local musical artists in some iconic locations but also offering a peek at some hidden gems to be discovered in Inverness County. The goal of this initiative is to support and promote our local artists, venues, businesses as well as trails, beaches and harbours. Each Monday's post will feature a musical video or photos supporting local events and venues.

UPDATE: Transfer Station Operations – Erin Gillis, Operations Manager

The new truck and trailer for the Transfer Station has arrived. Beginning on Tuesday, September 8th, appointments will no longer be required for residents visiting the Transfer Station. Social distancing rules will still be enforced going forward. A fall heavy garbage pick up is in the planning stages. Staff are working on a Request for Proposals to be issued for this initiative.

DEPARTMENT OF TRANSPORTATION AND INFRASTRUCTURE RENEWAL – Over Estimate Memo

Correspondence was received from the Department of Transportation and Infrastructure Renewal (TIR) regarding agreement 2020-029 Highway 105 Route 252 sidewalk/water/sewer. A response for this tender was received. The tender amount came back as significantly higher than what was estimated; a 51.3% increase from the original estimate.

Municipal Infrastructure Servicing - \$54,275.00 increase from the estimate.

Sidewalk Project - \$200, 024.50 increase from the estimate.

Recommendation from staff that the Municipality tender the process for the sidewalk construction independently from TIR and continue with the Municipal Infrastructure Servicing portion of the project.
