#### **BUSINESS ARISING**

## 2021 J CLASS ROAD POGRAM

Council was provided with a list of J Class Roads within the Municipality. CAO MacDonald informed Council of the procedure involved with these roads receiving upgrades. Councillors with J Class Roads in their district will be asked to submit their priority roads. The complete list will in turn be submitted to the Department of Transportation and Infrastructure Renewal for consideration.

#### FIRST READING: AMENDMENT TO THE BY-LAW 30: CAPITAL COST OF WATER AND SEWER

Director of Finance Tanya Tibbo addressed Council, and provided an overview of the costs associated with the water and sewer extension provided to the residents of Silverwood Lane, Inverness. The frontage rate is set at \$47.77 per lineal foot.

UPDATE: WHYCOCOMAGH LIFT STATION PROJECT

Melanie Beaton provided an update to Council. Currently in the village of Whycocomagh, a panel at Lift Station # 4 must be replaced immediately due to significant deterioration and safety concerns. Installation will include the new control panel, complete with explosion proof fittings, junction boxes, wiring and sealing compound. The estimated project cost is \$35,543.05.

## UPDATE: RECAPITALIZATION OF CENTRAL AVENUE, INVERNESS

Melanie Beaton provided an update to Council. In 2019, Dillon Consulting completed an assessment of existing water and wastewater infrastructure within the Municipality. The general condition of the linear infrastructure within the village of Inverness has been rated as very poor, indicating that it is physically unsound, unreliable, and has reached or exceeded its useful life. The estimated 10 year Investment Cost for the village of Inverness is \$42.6 Million, representing 41.3 % of the estimated asset replacement value.
