The Strait Area Mutual Aid Association was formed in 1976 by nine area Fire Departments. Their mission is continuous improvements to Fire and Emergency Services in the Strait Area. Their current membership 28 Departments from Richmond, Inverness, Guysborough and Antigonish Counties, the Town of Port Hawkesbury, the Town of Antigonish and the Town of Mulgrave. The Mutual Aid Agreement enables neighboring fire departments to respond to other coverage areas when requested, sharing resources, and equipment. Municipal support to the Strait Area Mutual Aid Association could enhance pagers, dry hydrants, and shared fire service equipment.
