

**VENDING PERMIT FEES POLICY**  
**MUNICIPALITY OF THE COUNTY OF INVERNESS**

<b>Policy Number:</b>	2021-06-17
<b>Effective Date:</b>	2021-11-04

**ARTICLE 1: Title**

- 1 (1) This Policy shall be known as the Vending Permit Fees Policy.

**ARTICLE 2: Authority**

- 2 (1) This Policy is made pursuant to Sections 172(1)(c) and (f), 172(2)(e), and 173 of the *Municipal Government Act*, SNS 1998, c 18, as amended and Section 14.1 of the Vending By-Law.

**ARTICLE 3: Definitions**

- 3 (1) In this Policy, the following words shall have the following meanings:
- (a) **"Municipality"** means the Municipality of the County of Inverness;
  - (b) **"Permit"** means a permit issued pursuant to the Vending By-Law;
  - (c) **"Permit Holder(s)"** means the Person(s) to whom a Permit has been issued pursuant to the Vending By-Law; and
  - (d) **"Person"** means a natural person, corporation, partnership, an association, society, firm, agent or trustee, and includes the heirs, executors or other legal representatives of a Person.

**ARTICLE 4: Annual Fees**

4.1 The fees to be paid to the Municipality for a Permit issued pursuant to the Vending By-Law shall be in accordance with the following table:

<b>PERMIT HOLDER</b>	<b>ANNUAL FEE</b>
Permit Holder is one individual who resides in the Municipality	\$500.00
Permit Holder is one individual who <u>does not</u> reside in the Municipality	\$1,000.00
Permit Holders are more than one individual, and at least one Permit Holder resides in the Municipality	\$500.00
Permit Holders are more than one individual, and no Permit Holders reside in the Municipality	\$1,000.00
Permit Holder is a business or other entity registered with the NS Registry of Joint Stock Companies, and the Registered Office of the business/entity is located in the Municipality	\$500.00
Permit Holder is a business or other entity registered with the NS Registry of Joint Stock Companies, and the Registered Office of the business/entity is <u>not</u> located in the Municipality	\$1,000.00

**ARTICLE 5: Special Event Fee**

5.1 The fees to be paid to the Municipality for a Permit issued for a special event pursuant to Section 13.20 of the Vending By-Law, shall be \$100.00 per day
