## 4. UPDATE: Chestley Carr; Director of Public Works, New SCADA System

SCADA (Supervisory Control and Data Acquisition) is in place within the Municipal Water Treatment Facilities. It is a digital network that can gather and analyze real-time data, allowing for high-level supervision of machines and processes. An operational overview can be accessed for any plant at any time. The lift stations will be on the Municipal SCADA system soon. Alarms can be received via text message, allowing for staff to respond to situations in a timely fashion.

#### 7. RINK REVITALIZATION FUND

The Port Hood & District Athletic Commission is seeking financial assistance to purchase a new Zamboni for the arena. The current Zamboni was purchased in 1994 and is a significant operational risk for the arena. The total project cost is \$154,662.00. The applicant has applied for one third of the project funding from the newly announced Rink Revitalization Fund Program (RRFP) or \$51,554.00. The applicant intends to fundraise \$20,173.00 in addition to providing a monetary contribution of \$51,554.00. The request of the Municipality is \$31,381.00.

Municipal staff has been directed to provide letters of support to the other three arenas in the Municipality (Cheticamp, Inverness and Mabou) towards any application they intend to submit to the Rink Revitalization Fund. Council will address any remaining applications that come forward from arenas at the November 18<sup>th</sup> Committee of the Whole.

#### 8. DOMESTIC BURNING

Provincial rules on domestic burning end on October 15<sup>th</sup>. Recent brush fires near the village of Inverness resulted reduced air quality.

Recommendation to staff to seek a legal opinion on whether the Municipality has the authority to address domestic burning and provide a recommendation to Council on whether or not to implement a policy or by-law on this issue.
