1. CALL TO ORDER

Deputy Warden MacIsaac called the meeting to order at 9:30 am and welcomed all in attendance. Roll call was taken. Acknowledgement was made that the land on which we gather is located in the ancestral and unceded territory of the Mi'kmaq people.

3. STAFF REPORTS

(a) Water and Wastewater Operations, Chestley Carr

The VTS/SCADA project within the water and waste water unit has been completed. The Requests For Proposals for snow removal for the upcoming winter season have been finalized. Control panel replacement projects continue at various lift stations and water treatment plants throughout the

Municipality. The new booster pumps have been received for the Broad Cove Banks Road booster station project. The sink/hot water heater installation project is nearing completion. The winterization of Municipal Fire Hydrants is nearing completion. Water and Wastewater sampling continues to ensure standards and guidelines are met. Multiple meetings within the department and with external partners continue.

(b) Infrastructure Unit, Ellen Murphy

Monthly highlights in infrastructure include water leak repairs, sewer repairs, and asphalt repairs. Asphalt and sidewalk repairs are completed. The water line replacement project for Laughlin Drive in Judique has been completed. Some of the streetlight repairs in the communities of Port Hood and Inverness have been completed with some new bulbs required for a few locations. Servicing work has been completed for the year with 21 property owners receiving new services to date. Multiple meetings within the department and with external partners continue.

(c) Erin Gillis, Operations and Occupational Health and Safety

Solid waste audits occurred at the Port Hood Administrative office and Strathlorne recycling facility recently. The recycling education campaign was launched. Job opportunities have been posted for both the Kenloch and Strathlorne facilities. The bylaw enforcement officer spent a day with the by law officers in the Town of Antigonish. The Illegal Dumping By Law is being developed. The Kenloch ground water well replacement remains delayed due to approvals to cross Crown land to access the wellsite. Numerous projects are underway in Kenloch and Strathlorne. Multiple meetings within the department and with external partners continue.

(d) Tanya Tibbo, Department of Finance

Property Tax activities included notice of tax sale letters, title changes, assessment changes and collections. Water Utility activities include collections, work orders, meter installs, disconnection letters, historical reads, curb locates, and water disconnections. Other department projects are underway including RFP development, land issues, cash receipting, accounts payable and the Volunteer Fire Department chiefs meeting. The Municipal Profile and Financial Conditions Indicators Results were presented. The overall assessment is low risk, which means that although the Municipality has a few challenges, it is considered low risk for fiscal instability. Multiple meetings within the department and with external partners continue.

(e) Donna MacDonald, Department of Tourism and Culture

Recent highlights within the Department of Tourism and Culture include the Judique and Margaree Brand and Signage Projects, and the potential partnership with Beinn Mhabu. Multiple department projects are ongoing including Winter Promotions, Coastal Experience Signage, Newcomer Welcome Groups, Canada's Musical Coast Website & Promotional Video, and CB Island Year of Music. Multiple meetings within the department and with external partners continue.

(f) Charlotte MacDonald, Department of Recreation

The deadline for Winter Active applications was December 6, 2021. The review of those applications is currently underway. In January 2022 the Recreation and Community Wellness will move from its current location at 375 Main Street to 86 High Road, Port Hood. Consultants will start interviewing Community Programmers, Recreation Organizations and providers in preparation for the Physical Activity Strategy & Recreation Master Plan. The Rental Equipment maintenance will begin next week. Multiple meetings within the department and with external partners continue.

(g) Melanie Beaton, Special Projects

Recent advancements have been made with the Inverness WTP, PW8 Upgrades, the Sanitary Sewer and Water Main Replacement Project in Strathlorne and Inverness, Judique well exploration, and the Cheticamp Wastewater Treatment Plant Outfall Replacement Project. Many miscellaneous projects are ongoing including asset management, physician and healthcare attraction and retention, the energy demand and renewable heat feasibility study, and numerous community development initiatives. Special projects staff are currently participating in training opportunities. Multiple meetings within the department and with external partners continue.

4. <u>PRESENTATION: CAPE BRETON PARTNERSHIP: Lynne MacLennan, Tyler Mattheis, Kelly MacKinnon</u>

The Cape Breton Partnership works to promote Cape Breton island as a place to work and invest. Staff connect businesses to the supports they need such as advisory services, marketing and promotion and strategic planning. In Inverness County, 123 new files have been started including business improvement, expansion and start up. Economic Development Projects such as the Strait of Canso gateway project and Housing Studies are underway. The Human Resources and Immigration Support Team are focused on supporting employers in meeting their staffing needs. The Cape Breton Job Board has 188 Cape Breton Employers signed up and actively posting. Settlement, Integration & Inclusion programs play an exceptional role to help make Cape Breton a destination of choice and support the settlement and integration of professionals and their families.

Pursuant to Section 4 (1) of the *Municipal Elections Act*, Council must appoint a returning officer to conduct the special election for District 1 Councillor will be held on March 5, 2022. Section 4 (1A) states that Council may also appoint an assistant returning officer who shall assist the returning officer in carrying out the returning officer's duties.
