### 4. PRESENTATION: JOE SHANNON

Joe Shannon is a resident of Long Point, Inverness County. He has concerns with the proposed Rhodena Wind Farm development project location; on 8000 hectares of Crown Land and private land, west of Highway 19. He is concerned about the potential for a loss of wealth if property values decline after this development project is in place. He encourages Council to not be in favour of this proposed location, and to make their decision known as soon as possible.

### 5. PRESENTATION: DAVE WILLIAMS; SEAWALL TRAIL

The Seawall Trail is a proposed multi day, forty eight kilometre hiking trail in Northern Cape Breton. The Trail will give local residents, hikers and residents a way to explore an isolated and valued wilderness area. The Seawall Trail Society was formed to facilitate the creation of the Trail. The Society's mandate is to develop walking assets in Northern Cape Breton by working closely with all stakeholders. They are currently waiting for regulatory approval from the Department of the Environment. Assistance by the Municipality to the Seawall Trail would be appreciated in the form of a Letter of Support to the Minister of the Environment, MLA and the premier.

### 6. WIND TURBINE BY-LAW

Dave Hart of Long Point, Inverness County presented the concerns of the Route 19 Community Association to Council regarding the proposed Rhodena Wind Farm Development. These concerns include:

- a. Health, safety, wellbeing, and protection of residents from activities that unreasonably disturb the peace and tranquility of the residents and the community.
- b. Protection, peaceful use and enjoyment of property; including the avoidance of activities that can create nuisances to residents, (noise, vibrations, and shadow flicker).
- c. Adverse effect to the environment (loss of animal habitat, impacts to birds and ground water).
- d. A lack of meaningful and transparent stakeholder engagement.
- e. Impacts to the cultural, historical, and the socio-economic profile of the community and the region.
- f. Governance (Bylaw review and update).

Recommendation to staff to work with the Eastern District Planning Commissions to update the Municipal Wind Turbine By-Law and Land Use By-law as it relates to wind turbines.

# 7. LES SUÊTES SIGNAGE

Concern was expressed by District 1 Councillor Claude Poirier regarding the lack of signs or warning lights for traffic in the Acadian Region of Inverness County during high winds.
