# 3. MUNICIPAL BOUNDARY REVIEW

They have provided Council with some options for realignment of Municipal Boundaries, none of which were selected as an ideal distribution of districts going forward. Two of the four planned public consultations were cancelled due to inclement weather and public response to the survey was small. The core principles of voter parity, representation of communities of interest and geographic size should be kept in mind when opting for changes to electoral boundaries.
