5. EASTERN DISTRICT PLANNING COMMISSION ANNUAL REPORT

A hard copy of the Eastern District Planning Commission (EDPC) annual report was provided to Council during the summer. EDPC Director John Bain will be present at an October meeting of Council to answer any questions or concerns with this annual plan. Bi-monthly staff reports from EDPC will be presented to Council going forward.

6. J CLASS SUBDIVISION ROAD SUBMISSION 2024-25

The Department of Public Works expects to fund, subject to budget approval, the paving, repaving, and double chipping of Subdivision streets during the 2024-25 construction year. Cost sharing will be fifty per cent for eligible streets. The Municipality will provide notice to the Province by October 31, 2023 of the priorities Council wishes to see addressed by this cost share agreement.

7. WIND TURBINE BY-LAW UPDATE

A Public Hearing originally scheduled for September 21st to discuss updates to the current wind turbine by-law was postponed to a later date to allow EDPC to conduct community consultations on the issue. EDPC staff will be present at the September 21st meeting of Council to provide an update on revisions to the current wind turbine by-law. Certain areas of the Municipality could be more favourable to wind turbine projects, especially locations in northern Inverness County. Council can provide feedback to the province in support of these initiatives in more remote, less populated areas of the Municipality.

8. STAFF DAY

Planning is underway to schedule a day focused on health and safety and training for Municipal staff. A day in late September or early October would be ideal. Notification would be provided to the public stating that Municipal services would not be available during that day.

9. NOISE BY-LAW

Councillor Chisholm noted that there is new legislation being introduced in Nova Scotia that aims to provide off-highway vehicle operators (ATVs) improved connections. Old East Street Road is one such connection. Councillor Chisholm would like to explore the idea of a municipal noise bylaw for the hours of 10 pm-6 am.

Direction to staff to explore updating the municipal noise by-law in light of new legislation regarding off-road vehicle operators.
