#### 4. PROCLAMATION: MI'KMAQ HISTORY MONTH

**WHEREAS** Mi'kmaq History Month was established in 1993 by the Province of Nova Scotia in partnership with the Mi'kmaq Grand Council, to recognize and celebrate Mi'kmaq culture and heritage; and

**WHEREAS** Treaty Day on October 1st celebrates the anniversary of the 1752 Treaty of Friendship and Peace, which is still in effect today; and

**WHEREAS** October provides an opportunity for all Nova Scotians to learn more about Mi'kmaq history, traditions, and contributions, and to strengthen relationships built on respect and understanding; and

**WHEREAS** the Municipality of the County of Inverness is located on the ancestral and unceded territory of the Mi'kmaq People, and acknowledges the importance of honouring this enduring connection; and

**WHEREAS** celebrating Mi'kmaq History Month supports the work of reconciliation and encourages a deeper appreciation of the Mi'kmaq Nation's role in shaping the past, present, and future of our province;

**THEREFORE**, I Lynn Chisholm, Deputy Warden of the Municipality of the County of Inverness do hereby proclaim

October 2025 as "Mi'kmaq History Month" in the Municipality of the County of Inverness.

We encourage all residents to take part in learning, reflection, and community events that celebrate the rich culture, history and ongoing contributions of the Mi'kmaq people.

### 6. PRESENTATION: MORGAN MURRAY, TRANSPORTATION STRATEGY PLANNING

With support from the Rural Transit Solutions Fund the Municipality is leading a collaborative public engagement project in partnership with Strait Area Transit (SAT) and L'Acabie to explore and improve rural public transportation across the region. This initiative aims to gather broad and inclusive community input to identify needs, gaps and opportunities for strengthening local transit

services. Engagement objectives include identifying gaps in current transportation services, understanding the needs of community groups, increase awareness of transit options and support the growth and sustainability of transportation services. The engagement strategy will involve 6 community sessions (1 in each municipal district) to gather general public feedback. These sessions are scheduled for late October and early November 2025.

# 12. <u>GRID (GROWTH AND RENEWAL INFRASTRUCTURE DEVELOPMENT PROGRAM) PROGRAM RESOLUTION</u>

**MOTION:** That Council supports the submission of the project MCI-TEN-2025-006 –

Lift Station #1 Replacement (Port Hood) for funding consideration under the Nova Scotia Growth and Renewal for Infrastructure Development Program.

**Whereas** Lift Station #1 in Port Hood was originally installed in the 1970s and has now surpassed its intended operational lifespan.

**Whereas**, the current Lift Station #1 is equipped with only a single pump, making it non-compliant with modern wastewater infrastructure standards that require redundancy.

**Whereas** the existing piping configuration at Lift Station #1 cannot accommodate the addition of a second pump, thereby preventing the implementation of necessary redundancy or capacity upgrades.

**Whereas** an active crack has been identified in the discharge piping of Lift Station #1, posing a risk of leakage and potential failure of the system.

**Whereas**, Lift Station #1 is not equipped with a backup power supply, resulting in possible sewage overflows during power outages and associated environmental and public health risks.

**Whereas** the Municipality of the County of Inverness is proposing the project MCI-TEN-2025-006 – Lift Station #1 Replacement (Port Hood) to replace the aging lift station and address these critical issues.

Whereas, the total estimated cost of the Lift Station #1 Replacement project is \$1,485,000, to be funded on a 50/50 basis by the Nova Scotia Growth and Renewal for Infrastructure Development Program and the Municipality of the County of Inverness (with the municipal share of approximately \$742,500 to be allocated in the 2026/2027 Capital Budget).

**Be it resolved that** the Council of the Municipality of the County of Inverness supports the submission of the project MCI-TEN-2025-006 – Lift Station #1 Replacement (Port Hood) for funding consideration under the Nova Scotia Growth and Renewal for Infrastructure Development Program.

Inverness County Council also commits to provide the required municipal contribution of fifty percent of the project cost (approximately \$742,500), with this amount to be included in the Municipality's 2026/2027 Capital Budget.

**WHEREAS** Section 66 of the Municipal Government Act provides that the Council of the Municipality of Inverness, subject to the approval of the Minister of Municipal Affairs and Housing, may borrow to expend funds for a capital purpose as authorized by statute;

**WHEREAS** the Council of the Municipality of Inverness has adopted a capital budget for this fiscal year as required by Section 65 of the Municipal Government Act and are so authorized to expend funds for a capital purpose as identified in their capital budget; and

**WHERAS** the Council of the Municipality of Inverness has determined to borrow for the purposes of Purchase of 2026 RAM 8 Yard Garbage Truck;

#### BE IT THEREFORE RESOLVED

**THAT** under the authority of Section 66 of the Municipal Government Act, the Council of the Municipality of Inverness borrow a sum or sums not exceeding two hundred and eight thousand, two hundred and twenty nine Dollars (\$208,229.00) for the purpose set out above, subject to the approval of the Minister of Municipal Affairs and Housing;

**THAT** the sum be borrowed by the issue and sale of debentures of the Council of the Municipality of Inverness to such an amount as the Council deems necessary;

**THAT** the issue of debentures be postponed pursuant to Section 92 of the Municipal Government Act and that the Council borrow from time to time a sum or sums not exceeding two hundred and eight thousand, two hundred and twenty nine Dollars (\$208,229.00) in total from any chartered bank or trust company doing business in Nova Scotia;

**THAT** the sum be borrowed for a period not exceeding Twelve (12) Months from the date of the approval of the Minister of Municipal Affairs and Housing of this resolution;

**THAT** the interest payable on the borrowing be paid at a rate to be agreed upon; and

**THAT** the amount borrowed be repaid from the proceeds of the debentures when sold.

# 14. MARGAREE AIRSTRIP COMMUNITY SURVEY

Results of the Margaree Airstrip Community Survey, held during the summer of 2025 were provided to Council. 129 residents responded to the survey. Overall, the responses show that while there is interest in diverse uses, many residents remain strongly connected to the site's aviation history and community traditions. The survey also asked residents what they would not like to see developed on the site. A recurring concern was the possibility of the land being acquired by private developers, which many feared would restrict public access. The top three community priorities for the site were: 1. Open and accessible to the public 2. Locally owned or operated 3. Supports the local economy or jobs.
