### 3. LAND ACKNOWLEDGEMENT

Warden MacIsaac acknowledged that the land on which we gather is located in the ancestral and unceded territory of the Mi'kmaq people and read the enclosed message:

This week many of us attended Remembrance Day ceremonies. I want to take a moment to speak about Indigenous Veterans Day Since 1994 it is recognized annually on November 8th in Canada. It commemorates the service and sacrifice of Indigenous veterans, while acknowledging historical injustices they faced.

- Over 4,000 Indigenous Peoples served in WWI, with some communities sending every eligible man between 20-35 years old.
- In WWII, over 3,000 First Nations, Inuit, and Métis individuals served, with many using their skills in marksmanship, tracking, and terrain awareness.
- An estimated 12,000 Indigenous members served in the 20th century, with 500 making the ultimate sacrifice.
- Indigenous languages, like Cree, were used to encode military communications, protecting vital information.

Indigenous veterans served with bravery and loyalty, yet faced inequities upon returning home, including denied benefits and land grants. This day honours their contributions and legacy, promoting recognition and reconciliation.

### 4. PROCLAMATION: COLTEN ELLIS

The following proclamation was read by Warden MacIsaac:

WHEREAS, Colten Ellis, a native of River Denys, Cape Breton, made his first-ever career start in the National Hockey League (NHL), marking a momentous milestone both personally and for the entire County; and

**WHEREAS**, after 25 years of hard work, dedication, and perseverance, Colten Ellis realized his lifelong dream of playing in the NHL, achieving a victory in his debut and earning two points for his team; and

**WHEREAS**, his debut performance made history as he became the first goaltender from Cape Breton to play and win in the NHL, and only the eighth goaltender born in Nova Scotia to reach this level of achievement; and

**WHEREAS**, the entire County of Inverness and communities across Cape Breton rallied behind him, celebrating not only his success but also the inspiration he brings to young athletes to follow their dreams; and

**WHEREAS**, this remarkable accomplishment has brought pride and recognition to the Municipality of Inverness County and the Province of Nova Scotia;

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the Municipality of Inverness County hereby congratulates and honours Colten Ellis for his historic NHL debut and win and expresses heartfelt appreciation for the positive example he has set through perseverance, passion, and community spirit.

### 6. PRESENTATION: MORGAN MURRAY, CABOT TRAIL 100th ANNIVERSARY PROJECT

October 2032 will mark the 100<sup>th</sup> Anniversary of Cape Breton's Cabot Trail. The route is contained within the counties of Victoria and Inverness and contains 298 km of highway most of which follow the rugged coastline with views of the ocean. Goals of the anniversary project include:

- Commemorate: Organize a year long series of events and activities that include collaboration with Mi'kmaw, Acadian, and Gaelic cultures.
- Engage: Encourage local communities along the trail to help plan and organize activities.
- Preserve and Enhance: Increase tourism to the region via international promotion.
- Project Management: Manage the project to effectively meet these goals and have a positive impact on stakeholders and rights holders.

## 12. <u>PUBLIC INPUT AND SECOND READING: BYLAW 64 – REPEAL OF BYLAW 36, PENSIONS</u> BYLAW

Warden MacIsaac asked if there were any oral or written submissions regarding the repeal of Bylaw 64 – Repeal of Bylaw 36, Pensions Bylaw. No written submissions were received. The following oral submission was made by Port Hood resident Marc Currie:

I hope that the following suggestion could be of use to current and future councillors. Instead of completely repealing the Pension Bylaw, replacing the wording with a requirement that a councillor may ask for, and if asking shall receive reasonable access to, or copies of all current pension related policies, practices, aggregate financial data, names of the corporations and/or individuals investing the pension funds, etc. In other words, all the information needed to full understand the current pension costs and future liabilities that the pension policies will have on the Municipality of the County of Inverness

One of the reasons that I make this suggestion is that in the news announcement of the Bylaw modernization it was stated that "current pension arrangements are now covered under updated human resources and personnel policies. When I looked on the policies webpage of the Municipality of the County of Inverness, I could not find any listed policy that was labelled "human resources and personnel policies". Such policies appear to be blocked to the public and I wish to ensure that these policies are not blocked to current and future councillors. Future councillors in particular will need to have this option to bring them "up to speed" on this "expenditure item".

Section 45 of the Municipal Government Act has required all municipalities to arrange for pension through a policy. Compliance with this provincial requirement seems to have been fulfilled, and as such, a rapid decision on the recommendation to repeal Bylaw 36 may not be the best long term choice. I urge Council to take time to consider how the Pensions Bylaw could be modified to the benefit of Inverness County.

I am not opposed to the repeal of this bylaw.

### 17. WHYCCOMAGH LIBRARY UPDATE

The new Whycocomagh community library will be located on the lower level of the Whycocomagh Waterfront Centre, 9650 Hwy 105.
