**1. CALL TO ORDER AND ROLL CALL**

**3. LAND ACKNOWLEDGEMENT**

Warden MacIsaac acknowledged that the land on which we gather is located in the ancestral and unceded territory of the Mi'kmaq people and read the enclosed message:

*Wli Eksitpu'k, Msit Wen (Welly Eksit-boog, Emsit When)*  
which means....

*Good Morning, Everyone...*

*The early relationship between the Mi'kmaw people and the French is a well known connection established likely in the early 1500's when the first wave of European settlers began to come across the Atlantic Ocean.*

*It is said that the Mi'kmaw established this strong relationship with the French based on the name of the French people in the Mi'kmaw language. Still today the name "Wenuj" / When-ooj " is used for the French (and the subsequently the Acadians). The name "Wenuj" when broken down in the Mi'kmaw language means "Who is that person" (as the first Mi'kmaw to meet the French explorers were likely expressing to other Mi'kmaw people, imagining a pointing of the thumb to a whole new race landing on the shores of Mi'kma'ki).*

*Other words that relate to the French that are still used in today's Mi'kmaw language are words like "Wenuj-tiam", (pronounced When-ooj-dee-ahm)... which is what we call the modern day "Cow" today but translated it actually means "French (Wenuj) / Moose (Tiam)".*

#### **4. PROCLAMATION: 16 DAYS OF ACTIVISM AGAINST GENDER-BASED VIOLENCE**

*The following proclamation was read by Warden MacIsaac:*

**WHEREAS** November 25 marks the International Day for the Elimination of Violence Against Women and the beginning of the 16 Days of Activism Against Gender-Based Violence; and

**WHEREAS** this global campaign, which runs until December 10, International Human Rights Day, raises awareness of violence experienced by women, girls, and members of the 2SLGBTQIA+ community, and calls for its prevention and elimination; and

**WHEREAS** the International Day for the Elimination of Violence Against Women was first declared in Latin America in 1980 to honour the Mirabel sisters, three political activists from the Dominican Republic who were assassinated in 1960 for standing against injustice, becoming enduring symbols of the fight for women's rights; and

**WHEREAS** in Canada, the 16 Days also encompass December 6, the National Day of Remembrance and Action on Violence Against Women, a day to honour the 14 women murdered in the 1989 École Polytechnique massacre; and

**WHEREAS** gender-based violence, including intimate partner violence, continues to impact individuals, families, and communities across our province, and recognizing it as an epidemic is an important step in acknowledging the seriousness of this issue; and

**WHEREAS** our municipality is committed to raising awareness, supporting survivors, and taking action to help prevent all forms of gender-based violence;

*THEREFORE I, Bonny MacIsaac, Warden of the Municipality of Inverness County do hereby proclaim November 25 to December 10, 2025, as the 16 Days of Activism Against Gender-Based Violence in the Municipality of Inverness County.*

## **10. CHETICAMP ECONOMIC DEVELOPMENT COUNCIL: COUNCIL SUPPORT FOR FCM INITIATIVE**

*Whereas, the Municipality of the County of Inverness has interest in supporting efforts to build climate resilience, particularly in areas of central economic value.*

*Be it resolved that the Council of the Municipality of the County of Inverness acknowledges that the Cheticamp Economic Council is applying for a funding opportunity from the Federation of Canadian Municipalities' Local Leadership for Climate Adaptation initiative for Climate Resilience in Cheticamp's Coastal Zone, Nova Scotia, in partnership with the Municipality of the County of Inverness.*
